Matters Arising	Aber Menai Agreement. CM – Updates the Board on changes to the lease at Aber Menai Point from Horizon Nuclear Power; wishing to transfer the benefits of the agreement to Great British Nuclear. They are able to do this without our consent (as it was written into the agreement). HM - in 2020, New Horizon needed an area for Tern relocation from Cemlyn, as part of their habitat assessment. The lease would only be triggered should the need arise to relocate Terns, at which point a fee would be applied. IH – Aber Menai point is designated as a National Nature Reserve (NNR) and a Site of Special Scientific Interest (SSSI) and therefore protected from any development.
