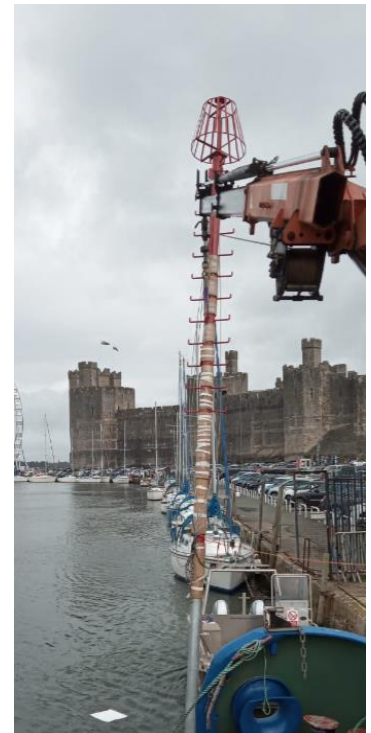
Further to my last, there still has not been a report produced. I will continue to pressure.

NAVIGATION

Work has proceeded well on the fabrication of the Mussel Bank perch. We now aim to complete early September.

Operational Stages

- Etch priming and the application of the topcoat to the perch section and top mark.
- The installation and fixing down of the receiving base. (Steel)
- The positioning of the first concrete ring and the casting of concrete. Up to 75% of the available volume.
- The installation of the second ring and the casting of the remaining concrete.
- The installation of the perch mast.
- The installation of the stainless stays.
- The fitting of the top mark and light.

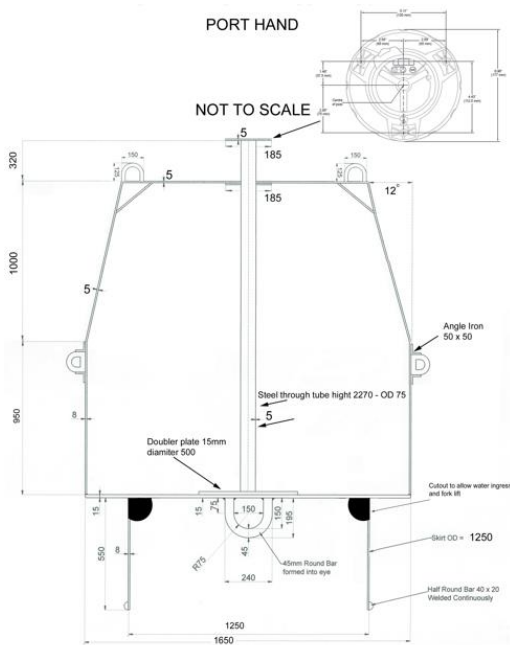

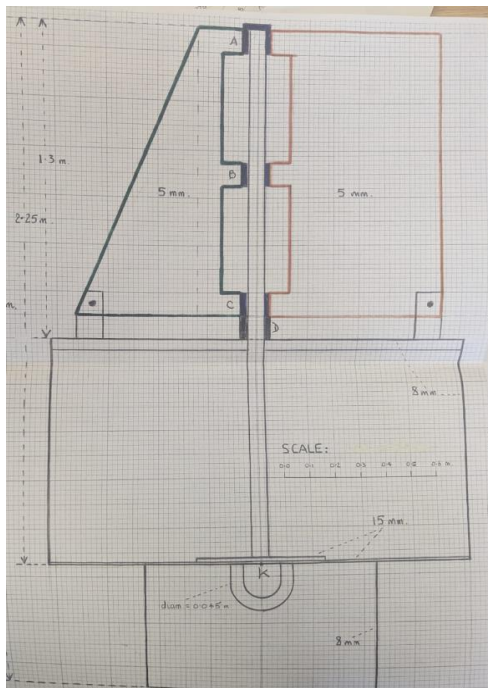
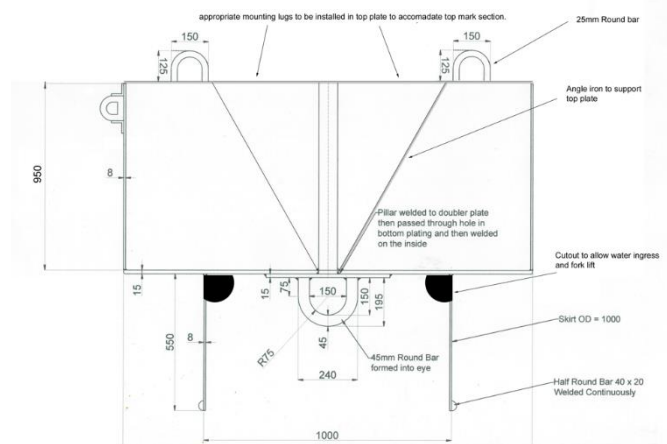
Part 1

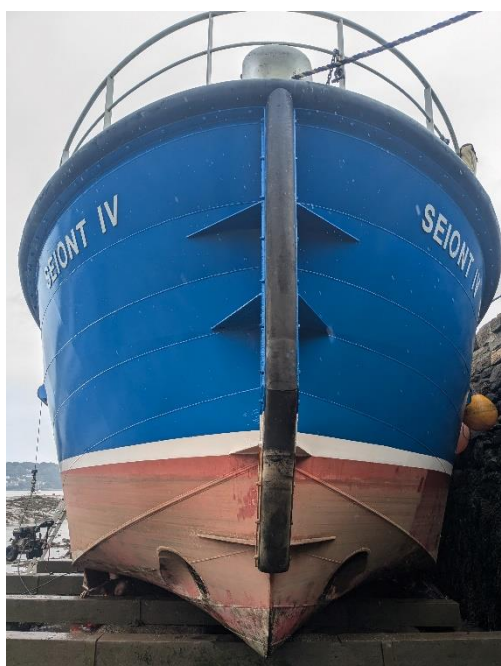
Pilotage
