3. Appoint Chairperson & Secretariat	3.1 The Harbour Master informed the meeting that under the 2012 Harbour Revision Order (HRO) it established a Marine Advisory Committee (MAC) comprising various stakeholders to advise the Trust. The meeting agreed to defer the decision to elect a Chairperson until the next MAC meeting, but that the Trust would provide the Secretariat.	СНТ
4. Purpose and Constitution of the MAC	4.1 The Harbour Master notified those present that: "The Trustees must take into consideration any matter, recommendation or representation which may from time to time be referred or made to them by the Advisory Committee whether or not the Advisory Committee has been consulted by the Trustees on the matter, recommendation or representation".	
5. Background information on the CHT	5.1 The Harbour Master reported that the CHT is a Statutory Harbour Authority established in 1793 by Act of Parliament. It is also a Competent Harbour Authority (i.e. as from 1988) with responsibility of pilotage throughout the Menai Strait. The Trust has a number of specific powers and duties. In any decision making following any discussions between the CHT and the MAC. It will be the Trust that has the final say. However, the Harbour Master emphasised that the CHT would not seek to be dictatorial, but rather discuss with the MAC what is the correct and appropriate solution for the benefit of all stakeholders. The MAC would provide a double check on what the Trust is doing, especially if the stakeholders have a better idea on what should be done. The Harbour Master highlighted that: "The Chairman of the Trustees, or his representative, and the Harbour Master, or his representative, shall be entitled to attend any meeting of the Advisory Committee". The Harbour Master reiterated that the Chairman of the CHT (I.C.Thomas) and himself are not nevertheless bound to come to a MAC meeting. In an answer to J.Judge, the Harbour Master stated that there was no reason why an individual could not only serve on the MAC, but also on the CHT. In fact the MAC should be an appropriate pool to recruit future Trustees. Mr I.C.Thomas remarked that it is a two way listening process. If the MAC and or a member can see that something is wrong or needs improvement the CHT will listen to every recommendation. Rather than wait until the next MAC meeting (if for example a breach of a Bylaw had occurred), the MAC and or a member should immediately notify the CHT. Just as there should be good communication between the MAC and the CHT, it must also apply within the MAC itself. To assist this process the Harbour Master will distribute at the end of this meeting a form to be completed by all the MAC members in order to collect the relevant email addresses, telephone numbers, etc. Mr I.C.Thomas informed the meeting that following the 2012 HRO	Harbour Master
